Application for Federal Direct Parent PLUS Loan 2009-2010

If you wish to borrow a Parent PLUS loan for your dependent student for the 2009-2010 academic year you must:

1. Be the parent of the student OR the step parent whose information is reported on the FAFSA.
2. File the Free Application for Federal Student Aid (FAFSA) with the Department of Education.
3. Complete all sections of this pre-application and return it to the Student Financial Aid Office (see below).
4. Sign the electronic Parent PLUS Master Promissory Note (eMPN) at the Department of Education's website at <http://dlenote.ed.gov>. You must know your Department of Education Personal Identification Number (PIN) to sign the Parent PLUS eMPN. This is the same PIN that you utilize to sign your student's FAFSA. The signature process is complete once you can view the screen that indicates SUCCESS! *Now Print your MPN.*

This form will be returned if any item is incomplete or not legible.
