## Contributor Information *(if required)*

A contributor is someone who is required to sign into your FAFSA with their own FSA ID. Not everyone who is required to provide information is required to sign in with an FSA ID. Who is required to sign in is determined by marital status at the time the FAFSA is filed and tax filing status for the year income is required on the FAFSA.

## DEPENDENT STUDENTS

Parent information will be required on the FAFSA. Here's how to determine who is a contributor.

### When parents are:

- **married and filed a joint tax return**, information for both parents is required but *only* one parent will need to sign in with an FSA ID.
- **married and filed taxes separately, or if biological parents live together but aren't married** information for *both* parents is required and *both parents* must sign in with their own FSA IDs.
- **divorced, separated, or never married AND don't live in the same household**, the parent who provides the most financial support must provide information and sign in with their FSA ID. If that parent is married, information for their spouse is required and the spouse must sign in with their FSA ID unless a joint tax return was filed.

## INDEPENDENT STUDENTS

If you are married, your spouse's information will be required on the FAFSA. If you filed a joint tax return, only you will have to sign in as a contributor.
